- 1. Pets should be kept on a leash of no longer then 6 feet during any rides, campouts or other MVATVR events. Please be a responsible pet owner and respect the rights of others.
- 2. Idaho State Law states that being under the influence and/or consuming alcohol or illegal drugs while operating an OHV is illegal and therefor will not be tolerated by MVATVR, Inc.
- 3. Generator use should be with consideration for others in camp and a recommended quiet time from 10:00 PM to 6:00 AM needs to be observed.
- 4. By operating your machine in a safe responsible manner, waiting at intersections and corners, you can insure that fellow riders will not be left behind and everyone will have an enjoyable ride.
- 5. Being a responsible member means, abiding by state motorized laws and obeying regulations for the area you are riding in, not disturbing wildlife, respecting the land and any private property that is crossed and closing any gates you open.
- 6. Please conduct yourself in a proper manner and strive not to be offensive to anyone, and respect the rights of others.

DIRECTIONS---Take Exit 216 from I-84 east of Burley (Declo exit HWY 77).

Travel south to Declo (4 mi) on Hwy 77. Continue south through Declo to Albion (8) miles.

Follow Hwy 77 thru Albion to stop sign (10) MILES. At stop sign turn right towards Almo/City of Rocks (16) miles. Go through Almo, ½ mile past Almo Oil. Road changes to gravel. Continue south about 1 mile to camp spot on right.

#### DO NOT TURN RIGHT ON CITY ROCK ROAD!

**SATURDAY**---ride will be to the south and east of camp to the Raft River Mountains. Ride will be around 65 miles. LEVEL 2--3 some 4.

#### 50 inch UTV"s and ATV's can travel this (nothing wider)

**SUNDAY**---travel west thru City of Rocks to Birch Creek Road then south to Lynn, Utah. Across Lynn Reservoir east towards Park Valley. Will head north over Raft River Mtns. Arrive back at camping area. Ride 60 miles. Wide UTV's welcome for this ride.

Camp area has no water or electricity. This is a private camping area. A donation of \$10.00 for the two nights stay on this private camp will be appreciated. I have made arrangements with the land owners for a reduced fee. Pay Jerry if you can, to offset what he has agreed to give them. Some of the rides will be on private ground. # **SAFETY CORNER**

#### Safety Topic – Article 4

As of June 21, 2014 summer is officially here. Many of us have ridden several miles this year and have enjoyed the great weather and trail conditions. As we move forward, I just want to remind everyone to reflect on my past safety messages and realize it only takes one mistake for a catastrophic event to affect us all.

As summer progresses, ranchers and sheepherders will be moving livestock from one grazing allotment to another. This means the chances of you encountering livestock on the trails and roads increase. So, be considerate when meeting livestock by slowing down or even finding an alternative route. It has been my experience most livestock handlers will move their animals out of the way so you can pass. Speeding up on a group of livestock could cause them to stampede or scatter. This will not leave a positive impression with the handlers, especially if they just spent several hours rounding them up to move. One other item to remember, if a gate is open then leave it open, but if the gate is closed when you arrive then close it behind you. Many grazing allotments and private lands will have signs asking you to close the gate. If the gate is not opened wide and lying against the fence then consider closing it.

MVATV members have two options for connecting into the forum:



#### TRAIL DIFFICULTY GUIDE

#### Level 1, Beginner:

Gravel or dirt surfaces that are relatively flat and wide. Generally wide enough for an ATV to pass a full-sized vehicle. May be dusty but are relatively smooth with no rocks or roots protruding more than three inches above the surface. Ride distance will be short, speeds very slow.

#### Level 2, Advanced Beginner:

Mild ups and downs, some narrow, mild rock, mostly roads and jeep trails, minor off camber. Two-wheel drive ok.

#### Level 3, Intermediate:

Loose gravel, sandy, rocky or rutty surface. May have short sections that are narrow. Can have blind turns, switchbacks, steep or roller coaster grades, some off-camber side hills, minor drop-offs, ruts and frequent changes in riding surfaces. Occasional obstacles may strike the frame. Four-wheel drive may be needed depending on conditions. Pace of ride will be a little faster, distances and length of ride will be longer.

#### **Level 4, Advanced Intermediate:**

Rocky surfaces, sharp turns, switchbacks, steep grades, narrow passages, low overhangs, ledges and large rocks. Can be slippery and muddy when wet. May have tree stumps, limbs or other debris. Machines with low ground clearance may strike or high center on obstacles. Four-wheel drive highly recommended.

#### Level 5, Expert:

Very rocky, steep, off camber, high water crossings, large ruts. Large obstacles in trails, narrow with big drop offs. Four-wheel drive required, may need winch.
